OFFICE ORDER

In pursuance of tender No. CREST/EOI/2022-23/12 published on dated 29.11.2022 for invitation of expression of interest for empanelment of Manufacturers/ System Integrators for Rooftop Grid connected SPV Power Plants in Chandigarh for F.Y. 2022-23, vide which 5 Nos. of bidders were empaneled by CREST in different categories for installation of SPV Power Plants in U.T., Chandigarh for capacity of 1 kWp to 500 kWp. **Residents of Chandigarh interested to install SPV Power Plants and want to avail upfront subsidy from Empaneled agencies have to install SPV Power Plants only from one of empaneled agencies of CREST.** But, the subsidy for the same shall be released to the Empaneled agency after commissioning of the project and receipt from MNRE (GOI) as per Office Memorandum no. 318/331-2017-Grid Connected Rooftop dated: 27.01.2023 or as decided by Ministry of New & Renewable Energy, Govt. of India, from time to time. The category wise L-1 rates arrived are as following:

The above said category wise L-1 rates for 1kWp to 500 kWp is applicable w.e.f. the date of issue of this order. The category wise details of empaneled agencies of CREST for installation of 1kWp to 500kWp SPV Power Plants in Chandigarh are enclosed in **Annexure-I** for further facilitation to general public of Chandigarh for installation of SPV Power Plants.

After installation and commissioning of SPV Power Plant, the Empaneled agencies are advised to inform CREST for its verification. **The Verification Report/ Joint Commissioning Report shall be forwarded to MNRE (GOI) for release of subsidy.** The subsidy as and when received from MNRE (GOI) shall be released to Empaneled agencies by CREST. The subsidy will be released to the Empaneled agencies only for the category in which they are empaneled.

Any Empaneled agency found violating the MNRE (GOI) guidelines Ph- II issued by MNRE (GOI) vide office memorandum no. 318/331-2017-Grid Connected Rooftop dated: 20.08.2019 and clarification issued vide letter no. 318/331/2017_GCRT dated 30.01.2020 and terms and conditions of DNIT for expression of Interest for empanelment shall be liable for delisting from the empanelment of CREST.
